Report of Voyage Ulithi, Carolines to Naha, Okinawa

(a) General Instructions for Commanding Officers of Naval Reference: Armed Guards on Merchant Ships, Par. 4301.

- (c) Contacts and action with the enemy: There was no contact and no action with the enemy at any time during the voyage.
- (d) General resume of the voyage: All Navy hands manned their Battle Stations at dawn and dusk during the entire voyage. On 30 July 1945 rough weather was encountered with typhoon conditions three to four hundred miles ahead across the course line. For two days the convoy sailed a circular course waiting for the storm ahead to move. Finally, at 1800 on 1 August 1945 we again pointed our bow towards Okinawa and held a steady course. The rest of the voyage was without event except for a short air alert early Sunday morning, 5 August. However, no planes were sighted and without further incident we arrived at Okinawa and anchored off Naha at 1255, 5 August 1945.
 - (e) There was no loading or discharging at Ulithi, Caroline Islands.
- (f) The commercial radio operators appeared to carry out wartime radio instructions and kept all intercepted messages confidential.
- (g) There were no defects to report to the Port Director at Naha, Okinawa.
- (h) The Master and officers of the ship carried out "Wartime Instructions for United States Merchant Vessels." Blackout regulations were strictly adhered to, bilges and waste materials were emptied at nightfall, routing instructions were obeyed, codes and signals were kept classified.
- (i) There are no recommendations to be made at this time for the improvement of the service.
- (j) There were no occasions of improper procedure on the part of friendly aircraft.
- (k) Practice in pointing, training and sightsetting was carried on when weather permitted.
