- (f) The two commercial radio operators appeared to carry out wartime radio instructions for merchant vessels, particularly in regard to keeping intercepted messages confidential.
- (g) No significant defects or deficiencies in location or arrangement of the battery, or in equipment as regards material, personnel or operation, have been noted.
- (h) The master and officers of the ship carried out "Wastime Instructions for Merchant Vessels".
- (i) There are no recommendations tending to the improvement or greater efficiency of the service to be made at this time.
- (j) No improper procedure on the part of friendly aircraft approching a merchant vessel was noted.
- (k) Training given at sea consisted principally of gun drills, use of cartwheel sights, spotting practice, American and Japanese aircraft identification, semaphore, use of Springfield rifle and .45 cal. Colt pistol, and safety precautions for ordnance on board, magazines and gunnery. T raining courses were distributed for private study, but to date no classes in them have been held.
