FACTS: Braxton Beasley was absent without leave on November 11, 1944, and March 13, 1944. The Captain logged him for these violations. Investigation showed there had been a misunderstanding between the Captain and Braxton Beasley as to his having received permission to leave the ship on these dates.

CONCLUSION: Due to the above stated misunderstanding between Braxton Beasley and there were no previous record on file against him with the Merchant Marine Hearing Unit, Washington, D.C. no charges were filed in this case.

BRAXTON BEASLEY WAS ADMONISHED ON 24 JULY, 1944 AND WAS INFORMED THAT HIS CONDUCT WAS UNDER SCRUTINY BY CREW MEMBERS AND THAT IF HE ACTING AS 3RD MATE COULD NOT GET HIS ORDERS CLEAR AND USE THAT FOR AN EXCUSE TO LEAVE THE SHIP THAT THE MEN WOULD UNDOUBTEDLY FOLLOW HIS EXAMPLE.

Plea: Specification 1 not guilty; specifications 2 and 3 guilty.



Facts: Harry H. McCaffey failed to stand two (2) watches on March 3, 1944. On June 28, 1944 he failed to join his ship at time of departure.


Conclusion: Charge and specifications proved by plea of guilty.
