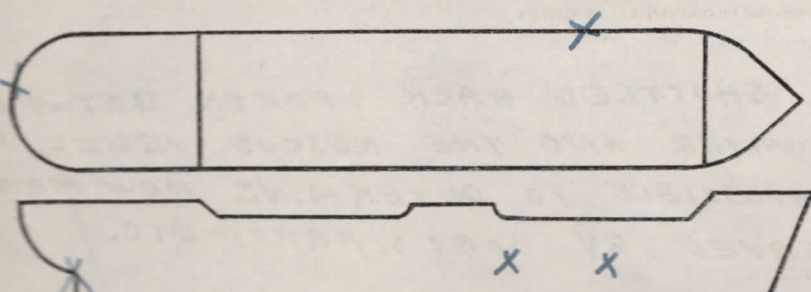

NOTE: - SINCE LIFEBOATS SHUTTLED BACK & FORTH BETWEEN SURVIVORS IN THE WATER AND THE RESCUE VESSEL, IT IS PRACTICALLY IMPOSSIBLE TO DETERMINE HOW MANY PERSONS WERE SAVED BY BOATS, RAFTS-ETC.
