2. Reference boarding report on S.S. "BOSTONIAN" submitted by this office, dated 18 November, 1944, relating to the above named person.

3. CARLOS GONCALVES DE AZEVEDO deserted the SS OLL HANSEN (Portugal) on 28 February, 1944, and since 6 March, 1944 has been aboard the SS BOSTONIAN employed in the capacity of A.B. Captain Thorvald M. KNUDSEN, Master of the SS BOSTONIAN, confirmed SUBJECT'S employment aboard ship, and stated that his services were satisfactory in every respect, and he plans to continue AZEVEDO aboard ship. AZEVEDO has Portuguese Passport No. 8728920A. Jacksonville Office of Immigration and Naturalization Service cognizant. AZEVEDO'S fingerprints are attached. AZEVEDO married in New York City in April, 1944, and his wife Margaret AZEVEDO resides at 360 Yale Avenue, Ossining, New York.
