Subj: DEGIFICO, Dominic, Z-102989-D1, SS CHARLES GLOVER

1. Subject signed aboard the SS CHARLES GLOVER as an AB on 17 August, 1945 at Naples, Italy, arriving Charleston, South Carolina on 19 September, 1945

2. The Subject departed the Port of Charleston, South Carolina, in June, 1945, on the SS ELEAZER LORD, bound for Italy. Subject advised that he was arrested in Naples, Italy by the British Military Police on 8 August, 1945, and charged with "off limits, striking an MP, attempted escape". The Subject was given a court-martial at the 8th Port Of Embarkation, Naples, Italy, and fined "\$50 and confinement with hard labor for 10 days." The Subject further stated that the Captain of the LORD would not bail him out and that he was paid off the ship at Naples and left there to serve his time; that he spent 10 days at hard labor in Naples. Subject advised that when he had served his time he was released and then reported to the United Seamen's Service Hotel at Naples on 16 August, 1945. Subject stated that he was assigned to the SS CHARLES GLOVER as an AB on 17 August, 1945 by War Shipping Administration, Naples, Italy.

3. Subject advised that he was born in Portland, Maine, on 3 March, 1926; that his father and mother were both born in Italy but are now naturalized citizens of the United States. The Subject further advised that he has been going to sea since he was 15 years of age; that he has been a member of the National Maritime Union for the past two years. Subject advised that he has sailed on the following ships since 1942:

1. Subject signed aboard the SS CHARLES GLOVER as an AT on 17 August, 1945 at Naples, Italy, arriving Charleston, South Carolina on 19 September, 1945.

2. The Subject deserted the Port of Naples, Italy, on 17 August, 1945, on the SS BLEAKER LONG, bound for Naples, Italy. He was arrested in Naples, Italy by the British Military Police on 8 August, 1945, and charged with "off limits", striking an MP, attempted escape. The Subject was given a court-martial at the 8th Port of Embarkation, Naples, Italy, and fined \$50 and confinement with hard labor for 10 days. The Subject further stated that the Captain of the LONG would not sail his crew and that he was paid off the ship at Naples and left there to serve his time; that he spent 10 days at hard labor in Naples. Subject advised that when he had served his time he was released and then reported to the United Seamen's Service Hotel at Naples on 16 August, 1945. Subject stated that he was assigned to the SS CHARLES GLOVER as an AT on 17 August, 1945 by War Shipping Administration, Naples, Italy.
