1. Pursuant to a report of oil spill on the SS CHARLES L. WHEELER, received on 21 July, 1945 from the COTP, the undersigned Examining Officer boarded the vessel upon her return to Los Angeles Harbor on 13 August, 1945.

- FINDINGS OF FACT -

3. The SS CHARLES L. WHEELER is a freight vessel of 2205 gross tons, Official No. 216656, owned by the War Shipping Administration and operated by McCormick Steamship Company of Wilmington, California.

On 21 July, 1945 at approximately 1500 PWT, the SS CHARLES L. 4. WHEELER was at Berth 195, Los Angeles Harbor, taking on fuel oil from a Richfield Barge at a rate of approximately 900 barrels per hour. On the ship the operation was being handled by a chief engineer new to the ship, one W. Wood, and a completely green third assistant engineer, one J. D. Sherman. Wood was discharged four days later for another reason and Sherman was hospitalized the next day; thus neither of these persons was available for an interview when the Examining Officer was aboard. The master stated, however, that the spill, which was six to eight barrels, three to four barrels of which reached the water, occurred as a sole result of the inexperience of the then chief engineer and third assistant. The oil, being taken into the ship's No. 2 tank, backed up into the forepeak tank and overflowed; both from the vent and tank top. A Martin Ship's Service clean-up gang of twenty-five men was secured immediately and the spill cleaned up by the use of straw.

## - CONCLUSIONS -

5. The oil spill on the SS CHARLES L. WHEELER at Berth 195, Los Angeles Harbor on 21 July, 1945 resulted from the fact the personnel in charge were new to the ship and one of them had just obtained a license as third assistant engineer. There was no real evidence of negligence. Prompt and efficient measures were taken to rectify the pollution.

- RECOMMENDATION -

6. It is recommended that the case be closed.
