Approving the Sale Alien and Transfer
to Chinese Registry and Flag of the
S/S COAST BANKER

WHEREAS, The United States Maritime Commission on January 7, 1947, authorized the sale of the S/S COAST BANKER, Official No. 218059, to Robert C. F. Ho, a national of China, with the privilege of transferring said vessel to foreign registry and flag:

IT IS ORDERED, This 6th day of February 1947, that the approval required by Sections 9 and 37 of the Shipping Act 1916, as amended (46 U.S.C. 808 and 835), of the sale of the S/S COAST BANKER, Official No. 218059, to an alien as above set forth, with transfer to Chinese registry and flag, be, and it is hereby granted.

IT IS ORDERED FURTHER, That this approval shall be null and void unless the sale alien and transfer to foreign registry and flag, hereby approved, are effected within six months from January 7, 1947.

Modification of Approval of the Sale Alien and
Transfer to Chinese Registry and Flag of the

S/S COAST BANKER

WHEREAS, By its Transfer Order No. C-5027 dated February 6, 1947, the Maritime Commission approved pursuant to Sections 9 and 37 of the Shipping Act 1916, as amended (46 U.S.C. 808 and 835), the sale of its S/S COAST BANKER, Official No. 218059, to Robert C. F. Ho, a Chinese citizen, with transfer to Chinese registry and flag and;

WHEREAS, The Commission is advised that the Chinese purchaser named above desires to transfer title of the vessel to Robert C. F. Ho Company, a corporation organized under the laws of Delaware and of which Robert C. F. Ho, a Chinese citizen is the sole owner, and to document the vessel under the laws of the United States; that after its first outward voyage from a United States port under United States registry, and upon its arrival at a Chinese port, the vessel is to be retransferred from Robert C. F. Ho Company, Inc., to Robert C. F. Ho, a Chinese citizen individually, who will place the vessel under Chinese registry and flag.

IT IS ORDERED, This 28th day of February 1947, that the Commission's Transfer Order No. C-5027, dated February 6, 1947, be, and it is hereby modified so as also to approve the transfer of the S/S COAST BANKER, Official No. 218059, by Robert C. F. Ho Company, Inc., a Delaware corporation, to Robert C. F. Ho, a Chinese citizen, individually, all other terms and conditions of the Commission's Transfer Order No. C-5027 to remain unchanged.
