Enclosure No. 2 to Dispatch No. 897 of September 3, 1942, from the Embassy at Hebana COPY September 2, 1942. LIELORAHDUL This morning Mr. C. H. C. Pearsell and I had an interview with Comodoro J. Arguelles, in connection with the S. S. COLABLE case. Our discussion with Comodoro Arguelles had been delayed waiting for the issuance of a decree placing in his hands the full authority under the Cuhan Navy to handle all matters relating to shipwrecks, salvaging, etc. This decree was issued on August 26, 1942. Among other things, the decree provides and brings under the jurisdiction of the Navy all matters pertaining to wartime traffic, accidents, and transfers these authorizations from the former departments of the Government handling them; namely, the Captains of ports, Directors of Customs and the Treasury Department. The decree suspends, for the duration of the war, all rights to claim any reward under salvage to salvors of vessels and provides that compensation should only amount to the value of the work actually done and actual reasonable expenses involved. It is my opinion that the decree is broad enough to permit Comodoro Arguelles to settle the matter personally between the owners and crew of the ORIENTE, in connection with the COLABEE case. Comodoro Arguelles very definitely stated that he is ready to consider the case promptly as arbitrator and will not consider any unreasonable demands. It was agreed that early next week I would present the details of the case to him and he instructed me to go over the matter carefully with Comandante Villageliu, so that he (Comodoro Arguelles) may arrive at his final decision. Comodoro Arguelles apologized for the delays coincident to the consideration of this matter and indicated that same had been chiefly caused by the recent political crisis in the Government and assured us that he would give us every consideration in an endeavor to bring the matter to a speedy conclusion.
