

1. In compliance with Reference (a), References (b) and (c) are submitted, which give a detailed picture of the incidents, which have been checked by this office and found to be correct, except in Reference (b) that the Coast Guard fire boat had hose lines laid out but under instructions from the Chief of the Baltimore City Fire Department, the lines were not charged at any time but were merely held in readiness. No water was pumped by the Coast Guard fire boat at all.

2. The Coast Guard first became cognizant of this fire at approximately 0150 when H. M. Hosel, Chief Specialist, Officer in Charge of C.G.C. #913-F, on standby duty at Pier 4, Pratt Street, heard fire engines responding to an alarm. Upon going on deck and looking around the harbor, he saw the fire at the Bethlehem Steel Company, Key Highway plant. The C.G.C. #913-F immediately got under way and proceeded to the fire, where the Officer in Charge, upon his arrival, immediately reported to the Baltimore City Fire Chief who was in charge of the fire. As there was no need for even this fire boat, no additional Coast Guard equipment was called.

3. The Bethlehem Steel Company admitted complete responsibility as the fire was caused through fault of one of their employees. The Commanding Officer, Baltimore Base, accompanied by the Assistant to Industrial Manager, USN, Baltimore, conferred with Mr. J. M. Willis, General Manager of the Bethlehem Steel Company plant. As a result of this conference it was agreed that the Baltimore City Fire Department would be notified more promptly through a better method of procedure,

namely, by sounding alarms from a fire alarm box, and for this purpose two fire alarm boxes have been installed in the Key Highway plant. Additional stress will, of course, be placed upon compliance with the Company's orders to see that no repetition of the failure to observe safety precautions is again suffered.
