Edward Claton DAIGLE, Z-286243 is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Panama on 16 July, 1945. SUBJECT man maintains that he signed on as Chief Electrician aboard the SS CAPE POSSESSION on 11 June, 1945 at New York, and arrived at Panama on or about the 20th of June, 1945. DAIGLE states that shortly after the arrival of this vessel at Panama, he left the ship early in the morning in search of the Ship's Boatswain. SUBJECT man stated that when he came back to the docks two hours later his vessel had departed, and that he then reported to the agents office and was detained, in the Quarantine Station except for the three days that he served on the SS BATTLE ROCK as Chief Electrician, merely to go through the Panama Canal. DAIGLE claims to have a Passport and Z certificate number given above, but the only identification paper SUBJECT man holds at the present time is a Captain of the Port Identification Card No. 658592. DAIGLE, born 17 July 1923 at Springfield, Mass., single, resides at 144-23 223rd St., Lamelton, Long Island. Forms 2515 and 2765 prepared.

James J. HUCHES, Z-500040, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Cristobal, Canal Zone, on 16 July, 1945. SUBJECT man maintains that he signed on the SS FORT HENRY as a Messman at Passadona, Texas and arrived in Cristobal, Canal Zone, on 5 July, 1945. HUCHES stated that he was taken off the SS HENRY at Cristobal by the Local Coast Guard Authorities for a hearing on 6 July, 1945. SUBJECT man applied for a passport in Boston, Mass. HUCHES, born 7 December, 1923 at Waltham, Mass., single, resides at 48 Bedford St., Waltham, Mass. Forms 2515 and 2765 prepared.

David Oscar LUSE, Z-280993, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Panama, Canal Zone, on 16 July, 1945. LUCE states that he signed on the SS SIGNAL HILLS as a Cook on 30 April, 1945 at San Pedro, California, arriving in Panama on 13 July, 1945. SUBJECT man maintains that he left the ship at Panama because of illness, and remained ashore in the Quarantine Station until signing on the SS POINDEXTER. SUBJECT man holds U. S. Passport No. 56861. LUSE, born 25 December, 1897 at Ainsworth, Nebraska resides with his wife, Emma at 431 Dawson Street, Long Beach, California. Forms 2515 and 2765 prepared.

"J" "C" OSBIRN, Z-627838, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Balboa, Canal Zone, on 16 July, 1945. SUBJECT man states that he signed on the SS WARRIOR POINT as an Ordinary Seaman on 12 May, 1945 at San Pedro, California, arriving in Panama on 9 July, 1945 and leaving this ship in Balboa, C. Z. on 11 July, 1945. SUBJECT man states that he missed his ship due to his having been picked up by the local authorities for fighting. He spent four days in a Balboa Jail, and one day in the Quarantine Station prior to signing aboard the SS POINDEXTER. OSBIRN applied for a U. S. Seaman's Passport on 9 November, 1944 at New Orleans. OSBIRN, born 16 May, 1928 at Hamilton, Alabama, single, resides at Route 3, Batesville, Mississippi. Forms 2515 and 2765 are prepared.

Robert Eston JONES, Z-548066, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Balboa. Canal Zone on 16 July, 1945. SUBJECT man stated that he signed aboard the SS MISSION SABONA as a Water-tender on 11 August, 1944 at Los Angeles, California, arrived at Balboa, Canal Zone on 30 May, 1945 and departed this vessel at Balboa on 21 June, 1945 due to illness. SUBJECT man maintains that he was in the Gorgas Hospital, Balboa, from 21 June, 1945 until the time he signed aboard the SS POINDEXTER. JONES applied for U. S. Seaman's Passport on 2 August, 1944 at San Pedro, California. SUBJECT man, born 11 June, 1925 at Chino, California, is single and resides at 1665 North El Molino Avenue, Pasadena, California. Forms 2515 and 2765 prepared.

Ralph Hindmarsh SPOOR, COTP Card No. A-08056220, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway in Colon, Canal Zone, on 16 July, 1945. SUBJECT man stated that he was formerly 1st Assistant Engineer aboard the SS GRANADA, and that he had been on that vessel for the past three and one half years, signing on originally at New Orleans, Louisiana. SPOOR maintains that the SS CRANADA arrived in Cristobal, Canal Zone, on or about the 8th of July, 1945 and that he left the ship on or about the 8th of July, 1945 and that he left the ship on arrival due to illness, remaining in the Margarita Hospital, Cristobal, until the time he signed on the SS POINDEXTER. SUBJECT man born 9 October, 1883 at South Shields, England, holds British Passport No. 117771 issued 14 March, 1935, and is a British Subject; however, SPOOR has taken out first papers for U. S. Citizenship and has been granted permanent residence in this country by the Immigration Authorities. SPOOR resides with his wife Mabel and their one child at 23 Adam Street, East Rockaway, Long Island, New York. Forms 2515 and 2765 prepared.

Keith LeRoy BUNKER, Z-610849, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER on 16 July, 1945 at Balboa, Canal Zone as a workaway. BUNKER maintains that he signed on the SS MISSION SAN LUIS O'BISPO as an Oiler on 1 May, 1945 at San Pedro, California and after calling at Hawaii, Enawetok, Uliphe, and again at Hawaii, arrived in Balboa, Canal Zone, on 12 July, 1945, and that he left this ship due to medical reasons. SUBJECT man stated that he remained ashore in the Quarantine Station, Balboa, until signing aboard the SS POINDEXTER. BUNKER states he applied for U. S. Seaman's Passport on 27 April, 1945 at San Pedro, California and that he lost receipt for same. SUBJECT man is single; born 29 January, 1927 in Delta, Utah, and resides in Delta, Utah. Forms 2515 and 2765 prepared.

John Burton WAYNE, Z-609288, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER on 16 July, 1945 at Panama, Canal Zone, as a workaway. SUBJECT man maintains that he signed aboard the SS WHITE OAK on 21 May, 1945 at San Pedro, California. WAYNE maintains that he arrived in Panama aboard this vessel on 12 July, 1945 suffering from an injured leg, and that he remained in the Quarantine Station until signing aboard the SS POINDEXTER. WAYNE states he applied for a U. S. Seaman's Passport on 21 May, 1945 at San Pedro, California, but did not have receipt for application. Frank Clarence SEEVERS, Z-85967, is a repatriated seaman, He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT man signed aboard the SS FORT BRIDGER as 1st Pumpman on 14 April, 1945 at San Pedro, California, which arrived in Balboa, C. Z., on 1 July, 1945.

SEEVERS stated that he left the ship upon arrival and remained in the Gorgas Hospital, Balboa, until signing on the SS POINDEXTER. SUBJECT man maintains that he was in the United States Army from 22 April, 1919 to 15 July, 1921; from 2 February, 1921 to 3 September, 1925 and from 29 July, 1930 to 15 May, 1931. SUBJECT man further maintains that he was arrested in Mt. Clemens, Michigan, on a charge of forgery, sentenced to serve ten to fourteen years in the Jackson Prison on 12 February, 1940, and that he was given a conditional release on 21 February, 1945 after serving four years of his sentence. SEEVERS, born 25 November, 1902 at Cambridge Ohio, is single, and resides at 917A. Foster Avenue, Cambridge, Hhio. Forms 2515 and 2765 prepared.

SUBJECT man was born 14 April, 1918 at Cuyahoga Falls, Ohio, and resides with his wife Margaret Mae, and their three children, in Santa Barbara, California. Forms 2515 and 2765 prepared.

Wesley William CARTER, Z-58719, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT man signed aboard the SS VICKSBURG as 2nd Assistant Engineer on 23 March, 1945 at Baltimore, Maryland. After an extended tour of the Pacific Area on board this vessel SUBJECT arrived in Balboa, Canal Zone, on 5 July, 1945. SUBJECT was immediately hospitalized in the Gorgas Hospital, Balboa, upon arrival of this ship, and remained in the hospital until 13 July, 1945 at which time he stayed in the Quarantine Station, Balboa, until signing aboard the SS GEORGE POINDEXTER. SUBJECT man holds U. S. Seaman's Passport No. 79454 issued 3 February, 1943. CARTER was born 4 November, 1913 at Greenhead, Florida, is single, and resides in Goodsprings, Ala. Forms 2515 and 2765 prepared.

Herschell A. PETREA, Z-636320, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT man signed on the SS TORR-ANDE HILLS as Quartermaster on 29 April, 1945 at San Pedro, California, after a trip to the Philippine Is., and arrived at Balboa, Canal Zone on 11 July, 1945. SUBJECT man maintains that upon his arrival in Balboa he left the ship on shore liberty, overstayed his liberty and thereby missed the SS HILLS when it sailed. Seaman's Passport application receipt No. 406238 issued 18 January, 1945. PETREA was born 14 February, 1921 at Woodlake California, and resides with his wife, Patricia, and their child at 223 S. Alexandria Avenue, Los Angelos, California. Forms 2515 and 2765 prepared.

Karl Frederick BEECROFT, Z-421157, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. BEECROFT signed on the SS QUEBEC as Chief Mate on 6 May, 1945 at San Francisco, and after a trip to Ulithi, arrived at Cristobal, Canal Zone, on 12 July, 1945. SUBJECT man left the ship on 13 July, 1945 due to medical reasons and remained in the Quarantine Station, Cristobal, until signing on the SS POINDEXTER. SUBJECT man holds U. S. Seaman's Passport No. 164265 issued 3 January, 1944. BEECROFT was born 12 June, 1894 at New York, N. Y., and resides with his wife, Pauline, at 1241 Huntley Drive, Los Angeles, California. Forms 2515 and 2765 prepared.

David Foote MOYER, Z-526902, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT signed on the SS GEORGE W. KENDALL as an oiler on 9 June, 1945 at Norfolk, Virginia, and arrived at Cristobal, Canal Zone, on 5 July, 1945. SUBJECT man was hospitalized in Cristobal until 14 July, 1945. Blair Freeman DeTRAY, Z-462005, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT signed on the SS THE CABINS as a Quartermaster on 6 May, 1945 at San Francisco, California, and arrived at Balboa, Canal Zone, on 3 July, 1945. SUBJECT man maintains that he left this ship in Balboa on 12 July, 1945 due to his suffering from stomach trouble and that he remained in the quarantine station, Balboa, until his signing on the SS POIN-DEXTER. DeTRAY applied for a U. S. Seaman's Passport on 12 December, 1944 at San Francisco, California. SUBJECT man was born 17 September, 1884, at McClure, Ohio, is single, and resides at 224 Grafton Avenue, San Francisco, California. Forms 2515 and 2765 prepared.

Joseph Henry UZONYI, Z-409867, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT signed on the U.S. MV YAQUINA HEAD as a 2nd cook on 4 March, 1945 at Portsmouth, Va., and arrived in Balboa on 5 May, 1945. UZONYI maintains that he departed this vessel in Balboa on 30 May, 1945 in order to go to the hospital. SUBJECT man remained in the hospital until 14 July, 1945, at which time he stayed in the Quarantine Station until sighing aboard the SS POINDEXTER. SUBJECT man holds U. S. Seaman's Passport No. 131209 issued 21 September, 1943. UZONYI was born 18 November 1915 at Bethleham, Pennsylvania, is single, and resides at 70 Butler Avenue, Bridgeport, Connecticut. Forms 2515 and 2765 prepared.

Donald Clark DEAVER, Z-590684-Dl, is a repatriated seaman. He signed on the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Cristobal, Canal Zone. SUBJECT man signed aboard the SS GEORGE W. KENDALL as a Utility on 9 June, 1945 at Norfolk, Virginia, and arrived at Cristobal on 27 June, 1945. DEAVER maintains that he was hospitalized in the Margarita Hospital, Cristobal, for an appendectomy operation upon arrival of the SS KENDALL, and that he was detained in this hospital until 14 July, 1945, at which time he stayed in the Quarantine Station, Cristobal, before signing on the SS POINDEXTER. SUBJECT man has a U. S. Seaman's Passport waiver issued 19 May, 1945 at Norfolk, Virginia. SUBJECT man, born 4 August, 1926 at Tekamah, Nebraska, is single, and resides at South 16th and C Streets, Tekamah, Nebraska. Forms 2515 and 2765 prepared.

George Yarrow EDWARDS, Z-527613, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT man signed aboard the SS AMIENS at Philadelphia, Pennsylvania, as a wiper on 30 February, 1945, and arrived at Balboa, Canal Zone, on 14 July, 1945. SUBJECT man was taken off the ship upon arrival by the Coast Guard Authorities for a hearing, at which time his E Certificate, E-552747 was revoked as it was determined he is not adaptable for engine room duties. However the revocation papers state that he is not to be prevented from obtaining a certificate for the steward's department. SUBJECT man stayed in quarantine while ashore. EDWARDS was born 12 April, 1928 at Delaware County, Pa., is single, and resides at 703 Lindale Avenue, Drexel Hill, Pennsylvania. Forms 2515 and 2765 prepared.

William Gene PEER, Z-14148, is a repatriate seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. SUBJECT man signed on the M.V SABINE SUN as an oiler on 16 April, 1945 at San Pedro, California, and arrived in Balboa, C. Z. on 4 July, 1945. PEER maintains that he left this vessel on 5 July, 1945 and was arrested for being drunk on the same day and remained in jail in Balboa until his signing on the SS POINDEXTER, the MV SABINE SUN having departed in the interim. PEER holds U. S. Seaman's Passport No. 32638 issued 20 August, 1942. SUBJECT man, born 9 February, 1918 in Omaha, Nebraska, resides with his wife, Kay, and their two children, at 1535 E. Denni Street, Wilmington, California. Forms 2515 to Bataan and placed and 2765 prepared. oncentration Camp) from 6 January, 1942

Abe Harrison LANE, Z-574500, is a repatriated seaman. He signed aboard the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Panama. SUBJECT man maintains that he was sent to Panama by the Maritime Commission with orders to ship out on the first vessel needing his services, that came into port. SUBJECT man signed aboard the SS MISSION SAN JOSE at Balboa on 3 June, 1945 as a Messman and made one trip to Hawaii. When the SS MISSION SAN JOSE again arrived at the Port of Balboa on 13 July, 1945, SUBJECT signed off the vessel due to home troubles, and remained in the Quarantine Station in Balboa prior to shipping on the SS POINDEXTER. SUBJECT man applied for U. S. Seaman's Passport on 27 May, 1945 at Tampa, Florida. LANE, born 19 December, single, and resides at 107 Emily Avenue, Knoxville, Tennessee. SUBJECT man signed on the SS FORT ROBINSON as a messman on 23 June, 1945 at Baton Rouge, Louisiana, and arrived in Balboa on 28 June, 1945. KLUTTZ states that he left the ship upon arrival and was hospitalized in Balboa until 14 July, 1945 at which time he stayed in the Quarantine Station, Balboa, until signing on the SS POINDEXTER. SUBJECT man applied for U. S. Seaman's Passport on 12 June, 1945 at Tampa, Florida. KLUTTZ was born 10 October, 1927 at Concord, North Carolina, is single, and resides at 124 Maple Street, Concord, North Carolina. Forms 2515 and 2765 prepared.

Henry B. WILSON, Z-129960-D-2, is a repatriated seaman and Civil Service Employee. He signed on the SS GEORGE POINDEXTER as a workaway on 16 July, 1945 at Balboa, Canal Zone. WILSON signed on the USAT HUGH L. SCOTT as Boatswain on 23 October, 1941 at San Francisco, California. He arrived at Manila, Philippine Islands, on 27 November, 1941, and signed off the same day, taking a U. S. Civil Service job with the United States Army Quartermaster Corps at Manila. His address from time of arrival at Manila until the Japanese invasion, was the Pioneer's Club, Manila. WIISON was captured by the Japanese when they invaded Manila 2 January, 1942, and was taken to the Far Eastern High School there, locked in a room and held for registration. He escaped that night and finished up some demolition work for the U. S. Army. He was recaptured on 6 January, 1942 while trying to get to Bataan and placed in the Santa Tomas University (Concentration Camp) from 6 January, 1942 until 20 February, 1945 when he was liberated by F Troop and parts of G and H Troops, Fifth Cavalry, First Armored Division, United States Army. The day he was liberated, a Mr. NEAL of the War Shipping Administration took all Merchant Marine Seamen including SUBJECT man to the Marsman Estate at Manila, where SUBJECT man stayed until 24 Hebruary, 1945 at which time he was flown to Leyte and quartered on the MV UNICOI. On 28 February, 1945 he was assigned to the MV POINT LOMA as Able Seaman, and sailed to New Guinea, New Hebrides, back to New Guinea, Tacloben, and thence to Cristobal, Canal Zone, arriving 12 July, 1945. He departed the MV POINT LOMA 13 July, 1945, for shore liberty, and returned to the landing pier at 0800 14 July, 1945 in order to secure a launch to report back aboard the MV POINT LOMA. SUBJECT man states that he waited six hours for a launch which was supposed to leave the landing pier at 1000, At 1400 he left the pier to get something to eat and to find out from the War Shipping Administration about getting a launch. When he arrived at the pier head to go ashore his papers and pass were taken up with the remark that the "ship's passes had been cancelled", and he was taken to the Police Station. At the Police Station he phoned the WSA representative who advised him that the POINT LOMA had sailed at 1130 that day, and he was

told to report at the U. S. Seaman's Club for supper and lodging, and to report to a Dr. HARVICK the next morning at 0900.
