Approving the Sale Alien and Transfer to  
Honduran Registry and Flag of the  
Steam Screw JEFFERSON MYERS  
(ex-HANNAWA)

WHEREAS, An application has been filed by Pacific-Atlantic Steamship Company, Vancouver, Washington, for the approval required by Sections 9 and 37 of the Shipping Act 1916, as amended (46 U. S. C. 808 and 835), of the sale of the steam screw JEFFERSON MYERS (ex-HANNAWA), Official No. 220769, to "Compania Internacional de Vapores, S. A.", a Panamanian corporation, and the transfer of said vessel to Honduran registry and flag:

IT IS ORDERED, This 16th day of July 1946, that the approval required by Sections 9 and 37 of the Shipping Act 1916, as amended (46 U. S. C. 808 and 835), of the sale of the steam screw JEFFERSON MYERS (ex-HANNAWA), Official No. 220769, to an alien as above set forth, with transfer to Honduran registry and flag, be, and it is hereby granted upon the condition that there shall be no liens or encumbrances on record against said vessel in the Customhouse at its last United States home port at the time its transfer to foreign ownership, registry and flag is effected; and

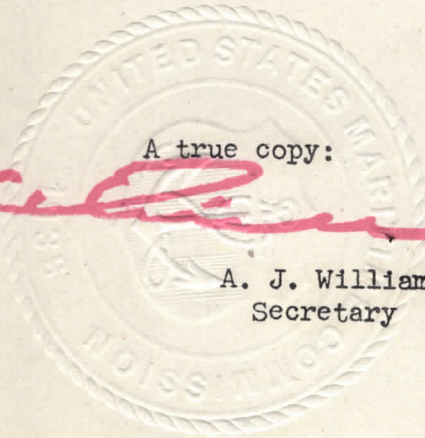

WHEREAS, by its Transfer Order No. C-4451, dated July 16, 1946, the Maritime Commission approved, pursuant to Sections 9 and 37 of the Shipping Act 1916, as amended, the sale of the S/S JEFFERSON MYERS, Official No. 220769, by Pacific-Atlantic Steamship Company, Vancouver, Washington, to Compania Internacional de Vapores, S.
