3. Charles E. THORN, 51, Utility aboard the SS LAWSON, is a repatriated American citizen. THORN was born in Duquoin, Illinois, on 6 January, 1894, and up until 1938 had been employed in Duquoin as a motor mechanic. In 1938, SUBJECT man maintains that he left this country in order to visit with some relatives in Warsaw, Poland. THORN stated that the "War got me in Warsaw, Poland, in September, 1939," and that he was arrested by the invading Germans on 28 October, 1941, and put in a "Heavy Labor Prison" in Cracow, Poland. SUBJECT man stated that he was kept in this prison until 26 July, 1944, at which time he escaped from the prison and "hid out with a Polish farmer in Cracow until January, 1945, when the Russians came in." THORN stated that after the Russians had gained control of Poland, he was permitted
