SUBJECT was formerly employed as 3rd Cook aboard the SS "MISSION DE PALA", but was confined to the Gorgas Hospital, Balboa, Canal Zone from 30 March, 1945 to 1 May, 1945, because of heart trouble. SUBJECT signed on the "JOSIAH PARKER" as a work-a-way for passage back to the United States. *Form FP*

3. The following seaman was employed as a work-a-way:

MILLINGTON, Robert Arthur, Z-631818, age 20. SUBJECT was formerly employed as A.B. aboard the MT "OHIO". Signed off by mutual agreement with the Master 1 April, 1945 at Colon Cristobal, Canal Zone due to the Master taking no action to recover clothing which had been stolen aboard ship from the SUBJECT.
